Existing Bylaw Change to Section: Sanctioned Divisions Article: XV Page: 11

Proposal:

Change to include Cheer Canada:

1. Cheer Divisions – School and All Star cheer divisions will follow the Age Grid, Cheer Rules, & Glossary which dictates routine requirements and limitations as set out by Cheer Canada and/or the IASF. School and all star cheer divisions will be scored using Cheer Canada Methodology or an SCA approved scoring methodology. School and All Star cheer divisions will follow the Cheer Canada or an SCA approved image policy.

2. Dance Divisions – School and all star dance divisions will follow the Age Grid, Dance Rules & Age Divisions, which dictates routine requirements and limitations as set out by Cheer Canada and/or the IASF. School and All Star dance divisions will be scored using the Cheer Canada Dance Scoring Methodology or an SCA approved scoring methodology. All dance divisions will follow the Cheer Canada or an SCA approved image policy. The SCA Dance Scoring Methodology is as follows: SCA score sheets shall adopt the current USASF world's score sheet, with the addition of the heading definitions and rubric range. The SCA score sheet shall be accompanied by a judges' tracking sheet which allows judges to keep track of the scoring throughout the competition. (Comparative scoring). Dance routines shall be scored based on regional scoring, where the top teams in Saskatchewan can achieve elite marks.

Rationale:

Cheer Canada will be releasing competitive rules, divisions, age grids, scoresheets and scoring methodology over the next year. As Cheer Canada members and to unify cheer across the nation, the SCA is obligated to follow directives as mandated from Cheer Canada.
